#### **MINUTES**

#### 1. CALL TO ORDER

Chairman Wilson called the meeting to order at 5:34pm and stated there was a quorum present to proceed.

#### 2. APPROVAL OF MINUTES

a) March 17, 2025 Special Called CTC Meeting Minutes

Vice Chair Mosley motioned to approve, seconded by Councilman Raines. Vote 6-0 to approve.

#### 3. NEW BUSINESS

- a) Approval of Reimbursement to the Roads Department for Road and Sign Materials in the amount of \$21,676.66

  Councilman Raines motioned to approve, seconded by Vice Chair Mosley. Vote 6-0 to approve.
- b) Approval of Bid RFB 24-078.04: Chester CTC 2025 One-Time Money Program 2 State Roads to LCI-Lineberger Construction in the amount of \$498,159.69 *Councilman Raines motioned to approve, seconded by Vice Chair Mosley. Vote 7-0 to approve.*
- c) Approval of Bid RFB 24-078.01: Chester CTC 2025 One-Time Money Phase I to LCI-Lineberger Construction in the amount of \$1,697,338.78 *Vice Chair Mosley motioned to approve, seconded by Councilman Raines. Vote 7-0 to approve.*
- d) Approval of Bid RFB 2425-30: Chester CTC 2025 Resurfacing 9 Roads to King Asphalt in the amount of \$1,024,626.21

  Vice Chair Mosley motioned to approve, seconded by Councilman Bobby Raines. Vote 7-0 to approve.
- e) Transportation Alternatives Program (TAP) Grant Information
  Richard Turner, AMT Engineering
  Mr. Turner stated he had been working with Devon Bagley and Chester County School
  District on a TAP grant application to create a sidewalk project along Village Drive and
  McCandless Road, connecting the Woodhaven subdivision to the middle school. The
  project was estimated to cost \$1.7 million, with a 20% local match. As a tier three county,
  Chester County could potentially reduce the match to 10%. The school district would
  contribute \$174,000, with \$50,000 coming directly from them. Administrator Hester
  added that the developer of Woodhaven and a private donor might also contribute to the

project. The grant would be federal money administered through SC DOT, with implementation spread over three to five years. The project would create sidewalks and a shared use path, connecting new developments to the middle school and Chester Nature Park.

#### f) 2026 Scoring Proposal for Road Selection Process Devon Bagley, Public Works Director

Director Bagley reviewed the current and proposed formulas used to prioritize road projects funded by C funds. She noted that the existing ordinance prohibited the use of C funds on private property and outlined specific eligible projects like paving unpaved roads, intersection improvements, and traffic safety projects. The current formula assigned point values to factors such as residences, permanent homes, school bus usage, and churches, with varying weights. Director Bagley explained that her team studied another county's (Fairfield County's) approach and blended elements of both systems to develop a new formula. This updated version added considerations such as work order history, visual inspections, commercial or industrial presence, location in a projected growth area, whether the road is a through road, development density, and the age of prior paving. She emphasized that the proposed formula placed greater weight on inspection grades and treated residences and churches equally, while also incorporating commercial and growth-related factors.

Administrator Hester also explained that while the proposed road grading system provides a formula to evaluate roads, council members can still recommend and justify paving roads for their districts that may not score well. The formula is just a tool, and council retains the flexibility to make choices that best serve their constituents' needs.

# g) Approval of petition to SCDOT for ownership of McAliley Street associated with ADA improvements

Administrator Hester proposed taking ownership of McAliley Street, the road behind the courthouse, to facilitate ADA upgrades for the Family Court and courthouse. Mr. Hester explained that by making it a one-way street, they can better manage the road's grade and create necessary improvements. The project would involve repairing sidewalks and resurfacing portions of the road. Administrator Hester stated he had spoken with a building owner who had no opposition to the changes. He also informed Council that the conversion would also help with parking and accessibility, providing parking spots for judges, the solicitor, and public defender and the street would become a county road, and the improvements would be part of the ongoing ADA project.

Councilman Killian motioned to approve the petition to apply for ownership of McAliley Street, seconded by Councilman Guy. Vote 7-0 to approve.
